Looking forward to your Annual Meeting

News from the Board

GREETINGS, FELLOW MEMBERS. At the July meeting, a concerned member addressed the board. Members should first direct their concerns to the administration at Lynch River. If the problem remains unresolved, the board will certainly listen.

The board decided members no longer “must be present to win” the grand prize and door prizes at the Annual Meeting. The names of members who register and vote will be entered into the prize drawing. If you choose not to stay for the meeting, you will be notified if you win.

A Grand Prize of a \$1,000 credit on your electric bill will be given away for the first time at this year’s Annual Meeting.

It has long been rumored a previous board had passed retirement benefits and life insurance policies for itself. We now can confirm this did indeed happen. The retirement annuities purchased in February of 1999 cost the co-op \$357,407. The life insurance policies have cost the co-op \$483,721.70 to this point, but the co-op will be reimbursed the premium paid at the ultimate demise of the insured board member.

This program was offered to Lynch River by an insurance company working through the National Rural Electric Cooperative Association (NRECA). Some cooperatives in South Carolina signed up and Lynch River was one of them. We are releasing this information to end the rumors and, hopefully, put this behind us. The current board is committed to a policy of openness and the highest level of integrity.
